2. DURATION OF THE PROGRAMME

The Duration of the Programme is 4 Academic years comprising of 8 semesters.

3. CLASS HOURS

Classes will be held from 6.15 p.m. to 9.15 p.m. on all working days. Candidates seeking admission should be in a position to attend the classes in the evenings and fulfill the requirements regarding attendance as per the Regulations of the University in force.

4. ELIGIBILITY FOR ADMISSION

Candidates satisfying the eligibility conditions given below as on the last date of submission of application are eligible to apply.

a) Qualification:

Candidates seeking for admission to the first semester of the Eight semesters B.E. / B.Tech. (Part –Time) Degree Programme shall be required to have passed the Qualifying Diploma Examination in Engineering / Technology in the relevant branch of specialization conducted by the State Board of Technical Education, Tamil Nadu or Other State or any other equivalent examination recognized by Anna University.

b) Year of Passing Diploma:

Candidates should have passed the diploma examination in the relevant branch of specialization at least two years before the last date prescribed for the Registration of Application.

c) Age Limit:

No Age limit is prescribed for admission to B.E. / B.Tech. (Part –Time) Degree Programme.

d) Employment:

(i) Current working professionals at the time of application with two years of work experience

(OR)

- (ii) Professionals with two years of work experience.
 - On the last date prescribed for the registration of application, candidates should have a minimum of two years of full time work experience (24 months) in a Registered firm / Industry / Educational Institutions/ Government and Autonomous organizations. in the relevant field in which admission is sought.
 - Only the experience gained after successfully passing the Diploma will be considered.
 - Periods of Training / Apprenticeship will not be counted as experience.
 - For current working professionals, the place of work should be within a distance of 90 km from the college to which he / she seeks admission so as to enable him / her to attend the classes regularly by 6.15 p.m. Further, the place of working should be in Tamil Nadu.

e) Mode of Study:

The mode of Diploma study shall be Full Time or Lateral Entry or Part-Time. **Candidates studied** in distance mode are not eligible.

- O If the Qualifying Diploma is not listed in the above table, candidate can select the Qualifying Diploma related to the Diploma of the candidate. The Candidates who have obtained their qualifying Diploma which is not mentioned in the above table have to obtain the eligibility Certificate from the Directorate of Technical Education / Director, Centre for Academic Courses, Anna University and should submit the same without fail.
- o Any course shall be offered only if the admission strength in that branch is more than 15.
- o If the number of Applicants registered for a particular branch is less than 15 the applications of that branch will not be processed and that specific branch will not be offered for the Academic Year 2024-25.
- If the number of candidates who participated for Online Counseling is less than 15 in any branch, Tentative Allotment will not be published. That specific branch will not be offered for the Academic Year 2024-25.

6. PREPARATION OF MERIT LIST

(i) Marks for Qualifying Diploma Examination

Marks obtained by the candidate in the qualifying Diploma Examination shall be reduced to 75 marks as detailed below:

(ii) Marks for Work Experience

Marks for work experience shall be calculated from the succeeding month of passing the Qualifying Diploma Examination to the last date prescribed for the registration of application. Maximum 25 marks for work experience shall be calculated as follows:

(iii) Preparation of Merit List

Merit list will be prepared as per rank based on the marks obtained by the candidate in the Qualifying Diploma examination and the marks awarded for the period of service adopting the weightage in proportion 75:25 and evaluated for a total of 100 marks.

In case where more than one candidate have got the same marks in the common rank list, inter-se rank among such candidates shall be determined in the order of priority as given below:

- 1. Total years of experience
- 2. Total marks obtained in the Qualifying Diploma Examination (Refer item No. 6.(i))
- 3. Date of Birth (Senior will be placed above)
- 4. Random Number

7. COMMUNAL RESERVATION

- **7.1.** Selection shall be made based on the rules of communal reservation of the Government of Tamil Nadu under seven categories viz., OC, BC, BCM, MBC & DNC, SC, SCA and ST.
- **7.2.** Tamil Nadu Native Candidates alone will be considered for communal reservation. The list of communities is given in **Annexure I.**
 - a) Candidates seeking admission under BC / BCM / MBC & DNC / SC / SCA / ST reservation should obtain the certificate of social status issued by the competent authority in the Permanent Community Card Format / Digitally Signed e-Certificate issued by the Government of Tamil Nadu and upload a self-attested photocopy of the same along with the online application. Community Certificate in paper format will not be accepted.
 - b) The applicants from Tamil Nadu State should have obtained permanent community certificate in card format or Digitally signed e-certificate only from the authorities given in the table presented below.

Married women should possess Community Certificate issued in Father's name only.

c) For communities linked with districts (**Refer Annexure-I**) the candidates should obtain their Community Certificate in their respective districts. Community Certificates obtained from other than their respective districts will not be considered and they will be treated under Open Competition category. However, candidates who belong to **BC**, **MBC and DNC communities** in a particular district, who migrated to other places in Tamil Nadu and obtained Community Certificates from competent authorities in the migrated district on or after 28.10.2009, will be considered (as per G.O. (St) No. 95 BC, MBC & Minorities Welfare Department, dated 28.10.2009).

- d) Community Certificate obtained from **Other States** will not be considered for communal reservation.
- e) Candidates who have not uploaded the self attested photocopy of the Permanent Community Certificate in Card Format / Digitally signed e-Certificate at the time of submission of the application will be treated under **OC Category**.
 - f) Candidates who have passed IX std / X std / Qualifying Diploma Examination outside Tamil Nadu will be considered under Open Competition category only. However, Tamil Nadu Native candidates who have studied either IX std or X std or Diploma outside Tamil Nadu and claim communal reservation should upload a copy of Nativity Certificate only as digitally signed e-Certificate along with the filled in online application. Otherwise they will be considered under OC category.

8. NATIVITY CRITERIA

- i. Tamil Nadu candidates who have studied (for the last 5 years) IX/ X /XII/ Diploma in Tamil Nadu are eligible to apply. They need not enclose Nativity Certificate.
- ii. Other State candidates who have studied (for the last 5 years) IX/ X /XII/ Diploma in Tamil Nadu are eligible to apply. They need not enclose Nativity Certificate.
- iii. Tamil Nadu Native candidates who have passed any of the IX, X, XI, XII, Diploma from the Institutions situated outside Tamil Nadu can also apply. They should enclose a copy of Nativity Certificate.

Note: Tamil Nadu native candidates alone will be considered for communal reservation.

Others will be considered under "Open Competition" (OC).

9. DIFFERENTLY ABLED PERSONS CATEGORY

Five percent of seats are reserved for Differently Abled Persons @ 1% for each of the following category:

- a) Blindness and low vision.
- b) Deaf and hard hearing.
- c) Locomotor disability including cerebral paisy, leprosy cured dwarfism acid attack victims and muscular dystrophy.
- d) Autism, intellectual disability, specific learning disability and mental illness.
- e) Multiple disabilities from amongst persons under clauses (a) to (d) including deaf-blindness in the programme identified for each disabilities
- The Competent Authority to issue Disability Certificate is <u>District Medical Board</u> duly constituted by the State Government. *The District Medical Board shall consists of a minimum of three members (Chairman and two Members) out of which atleast one shall be a specialist depending on the disability prescribed.*

Certificate obtained from an individual doctor will \underline{NOT} be considered.

10. COUNSELING PROCESS

The counseling for admission for the Academic Year 2024-25 will be conducted only through Online Mode. Once the Rank list had been published candidates can access the Web Portal for exercising the Choice of the Campus / Branch of the Study. Prior to a candidate exercising his / her choice, the candidate will have to pay (through Online Mode) an Initial Deposit and also Non-Refundable Counseling Fee.

OC / BC/ BCM / MBC & DNC candidates:

Initial deposit of Rs.10000/-

Non-Refundable Counseling Fee of Rs.300/- (+18% GST)

SC / SCA / ST candidates:

Initial amount of Rs.10000/-

Non-Refundable Counseling Fee of Rs.150/- (+18% GST)

CHOICE ONCE MADE IS FINAL AND CANNOT BE CHANGE.

An applicant who declines after the publication of Tentative Allotment OR an applicant who is not allotted a Branch during Provisional Allotment shall be eligible for 100% Refund of the Initial Deposit After provisional allotment, an applicant who does not join the branch allotted shall be eligible for 80% of Refund of the initial deposit. The candidates eligible for refund should apply through the Web Portal (cfa.annauniv.edu/cfa) within six months from the date of counseling. The application for refund submitted beyond six months will not be considered.

11. EMPOLYMENT DETAILS

a). PRESENT EMPLOYMENT CERTIFICATE

Candidates who are currently employed should submit the employment certificate in the prescribed format.

b). EXPERIENCE CERTIFICATE:

- Candidates with experience certificate issued by organizations / Institutions other than Government / Quasi Government Department should also upload any one of the following:
 - > TNGST Certificate / CST Certificate / TIN Certificate of the organization in which the candidate was employed.
 - ➤ Certificate of Registration under Companies Act. / SSI Registration Certificate / Certificate of any statutory body.
 - ➤ Government approved contractors registration certificate (current year) License No. with latest I.T. clearance certificate for private individuals other than companies.
 - > GPF statement & Pay slip.

- The Period of Training / Apprenticeship will not be counted for experience.
- The period of work experience will be taken from the succeeding month of passing the qualifying Diploma Examination till the last date prescribed for Registration of applications.
- Work experience will be taken into account only if the Registration / Certificate number of the company is clearly mentioned in the work experience certificate. Otherwise the period of experience will not be considered.
- Offer of appointment letter / relieving order will not be considered in lieu of work experience certificate.
- Date of joining and date of relieving should be clearly mentioned in the experience certificate.
- Work experience certificate(s) should be in the employer's letter head with TNGST / CST / TIN / TAN / RC / License No.
- If the candidate had worked in foreign countries, he/she should produce certificate in the employer's letter head clearly mentioning the date of joining and date of relieving and the nature of work. Further, copies of passport and work visa have to be uploaded. In the visa / passport, if the entries are in languages other than English, translated copy obtained from the authorized institution of the same in English should be produced.

12. LAST DATE FOR REGISTRATION

Registration of only one application is sufficient for University Departments of Anna University, Chennai (College of Engineering, Guindy, Alagappa College of Technology, Madras Institute of Technology, Chrompet), University College of Engineering BIT Campus (Trichy) and University College of Engineering Panruti Campus.

- a) Enter all the required data in the Online application form.
- b) The name should be entered as in SSLC or its equivalent certificate. Change in name / initial, if any, should be supported with Gazette notification.
- c) Payment of application fee of ₹ 600 /- (+18% GST) for OC / BC / BCM / MBC & DNC Category Candidates through Online Mode. Payment of application fee of ₹300/- (+18% GST) for SC / SCA / ST Category Candidates through Online Mode by using Credit Card / Debit Card / Net Banking. Application Fee is not refundable.
- d) The self-attested copies of the following documents should be uploaded:
 - (i) X standard mark sheet or its equivalent certificate
 - (ii) XII standard mark sheet (for lateral entry candidate)

ANNEXURE II

DIFFERENTLY ABLED PERSONS CATEGORY

Candidates seeking admission against reservation set apart for Visually Impaired, Hearing impaired (Deaf), orthopaedically Differently Abled Persons, Autism, Multiple disabilities should produce the certificate from the **Medical Board (minimum 3 doctors) of the District** concerned certifying the nature and **extent of disability in percentage** and with regard to his/her suitability for admission to the Programme in the format (Certificate No. I/II/III/IV/V). Certificates obtained from an **individual Doctor** will not be considered. **Further, a separate medical Board for each category will examine the candidates with reference to their certificates.**

Eligibility criteria for various disabilities

A. Norms for Visual Impairment

Candidates with low vision of 40 % and above are considered as disabled, and hence eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. II).

- 1. "Blindness" means a condition where a person has any of the following conditions, after best correction—
 - (i) total absence of sight; or
 - (ii) visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
- (ii) limitation of the field of vision subtending an angle of less than 10 degree.
- 2. "Low-vision" means a condition where a person has any of the following conditions, namely:—
 - (i) visual acuity not exceeding 6/18 or less than 20/60 up to 3/60 or up to 10/200 (Snellen) in the better eye with best possible corrections; or
 - (ii) limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.

Person with impairment of vision of less than 6/18 to 6/60 with best correction in the better eye or impairment of field in any one of the following categories:

(a) Reduction of fields less than 50 degrees, (b) Heminaopia with macular involvement, and (c) Attitudinal defect involving lower fields categories of Visual Disability all with correction.

B. Norms for Hearing Impairment

Candidates with hearing ability of 40 db and above only in the better ear with speech discrimination score of 50 % and above are considered disabled and hence eligible for claiming Engineering Admissions against Differently Abled Persons category (Certificate No. III).

- 1. "Deaf" means persons having 70 DB hearing loss in speech frequencies in bothears.
- 2. "Hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears.

C. Norms for Locomotor Disability

Candidates with permanent physical impairment of 40 % and above are considered as disabled. The candidates with Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy of the following typ es are eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. IV).

- **1. Locomotor disability** (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both).
 - (i) Independent in ambulance with <u>or</u> without calipers but without walking aids. (ii) Good Standing Balance without calipers but without any support. (iii) Hand Function with normal limit without any aid. (iv) Good control over bladder & bowel. (v) Disea se must be non progressive.
 - 2. "Leprosy cured person" means a person who has been cured of leprosy but is suffering from-
 - (i) loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
 - (ii) manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normaleconomic activity;

^{*} ONE EYED persons with normal vision are not considered as disabled.

- (iii) extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, andthe expression "leprosy cured" shall be construed accordingly;
- **3. "Cerebral palsy"** means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth:
- 4. "Dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- 5. "Muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, andthe death of muscle cells and tissue;
- 6. "Acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

D. Norms for Autism, Intellectual Disability, Specific Learning Disability and Mental Illness

Candidates with permanent physical impairment of 40 % and above are considered as disabled. The candidates with Autism, Intellectual Disability, Specific Learning Disability and Mental Illness of the following types are eligible for claiming Eng ineerin g Admission against Differently Abled Persons category (Certificate No. V).

- **1. "Speech and language disability"** means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.
- **2. Intellectual disability,** a condition characterized by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including—
- (i) "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dysprax ia and developmental aphasia;
- (ii) "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.
- **3. Mental behaviour** "mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub normality of intelligence.

4. Disability caused due to-

- (i) chronic neurological conditions, such as—
 - (a) "multiple sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelization and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
 - (b) "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidit y, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
- (ii) Blood disorder-
 - (c) "hemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterized by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
 - (d) "Thalassemia" means a group of inherited disorders characterized by reduced or absent amounts of hemoglobin.
- (e) "sickle cell disease" means a hemolytic disorder characterized by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane ofred blood cells resulting in the release of hemoglobin.

E. Norms for Multiple Disabilities

Candidates with multiple disabilities with permanent physical impairment of 40 % and above are considered as disabled and they are eligible for claiming Engineering Admission against Differently Abled Persons category (Certificate No. VI). Multiple Disabilities (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
